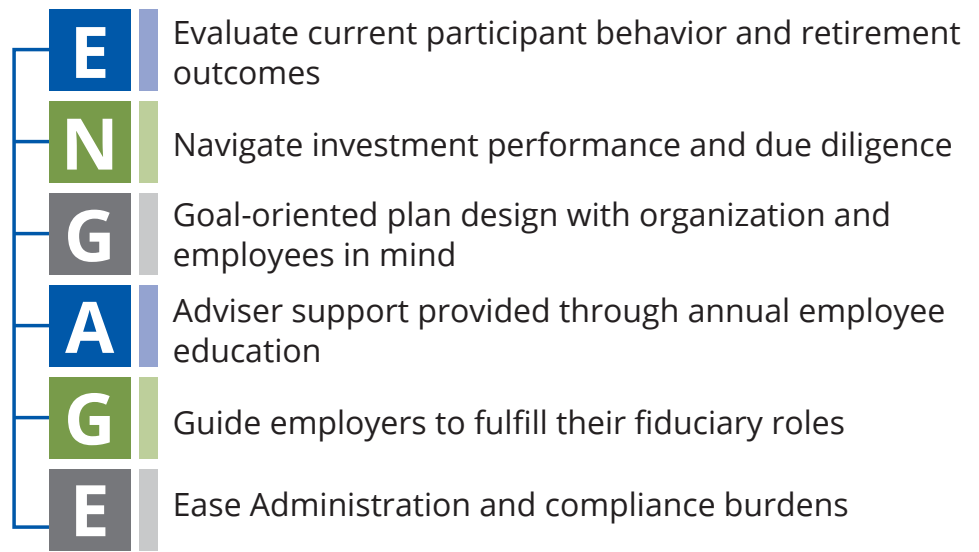

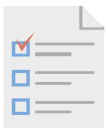

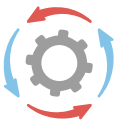
## DISCOVERY SESSION

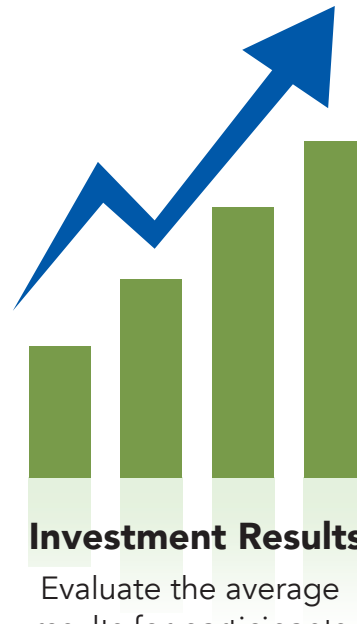
